1 Respective responsibilities of the body and the auditor

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2021; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2020/21

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with *Proper Practices* and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Section 1, Assertions 1-8 have been incorrectly completed, as they have all been ticked 'Yes' and 'No'. The authority must tick one box per assertion.

The smaller authority has not addressed the 'except for' matters raised by the external auditor when qualifying the prior year annual return.

- Boxes 1 and 6 in the comparative column should read £39,313 and £51,363 respectively.
- Boxes 2 and 3 in the comparative column should read £21,563 and £14,597 respectively.

The AGAR was not accurately completed before submission for review:

- Section 2, Box 7 for the prior year does not agree to Boxes 1+2+3-(4+5+6).
- The balance brought forward from the previous year of £19,624 (Section 2, Box 1) does not agree to the prior year balance carried forward of £22,157 (Section 2, Box 7).
- Section 2, Box 2, the annual precept, does not agree to the figure published by the precepting authority. The figures in Boxes 2 and 3 should read £22,000 and £7,010 respectively. All grants, including Council Tax Support Grant, should be shown in Box 3, as per the guidance notes on the AGAR.

The smaller authority has disclosed that it made proper provision during the year 2020/21 for the exercise of public rights, by answering 'Yes' to Section 1, Assertion 4. However, as was reported last year, we are aware that it failed to do this and therefore should have answered 'No' to this assertion. It has also disclosed that it took appropriate action on all matters raised in reports from internal and external audit, by answering 'Yes' to Section 1, Assertion 7, which, on the basis of the above, is not correct.

Other matters not affecting our opinion which we draw to the attention of the authority:

The smaller authority has not provided:

- an adequate explanation for the variance between the prior and current year values in Box 3, 6 and 9 of Section 2.
- an adequate explanation as to why the trust fund entries in Section 1, Box 9 and Section 2, Box 11 of the AGAR vary from the entries in the prior year final signed Annual Return.
